Subject:- Initial allotment of Lawyers' Chambers in Lawyers' Chamber Block, District Court Complex, Saket, New Delhi.

Whereas, consequent upon the decision taken in the Meeting of Lawyers' Chambers' Allotment Committee held on 30.07.2024 and considering the vacancy of Two (2) single occupancy chambers, their allotment is required to be offered to allottees of chambers on double occupancy basis in order of their seniority of NDBA taken into account for allotments during process of "Initial Allotment".

And whereas, all the allottees of chambers of double occupancy basis who secured chamber under "Initial Allotment", are hereby informed that they may apply for upgradation of their allotment from double occupancy to the said single occupancy chambers on or before **07.09.2024** subject to the conditions that the applicant has cleared dues of his/her existing chamber and fulfilling the following criteria set vide agenda Item No. 19 of MoM dated 20.09.2022 of Lawyers' Chamber Allotment Committee:

".....the Committee unanimously resolves that henceforth applications for up-gradation of Chamber shall be considered only of those allottees who regularly pay dues of their existing slot/ Chamber"

It is to further inform that as decided in the meeting of LCAC held on 30.07.2024 the applicants applied for upgradation of chamber in compliance of Notice dated 24.04.2024 & 07.06.2024 need not to apply again for above mentioned two (2) chambers of Single Occupancy. Their earlier application received in between 24.04.2024 to 18.05.2024 & 07.06.2024 to 20.07.2024 will be considered.
