In compliance of the Judicial Department G.O. No 39-JD/L/2S-23/04(Pt-VI) dated 18/02/2021, G.O. No 5142-J dated 20/07/2009, No 3444-J/ JD/II/16M-29/17 dated 21/08/2018, clarified vide Finance Department Memo No 4550-F(P) dated 11/06/2015 and direction of The Hon'ble High Court, Calcutta vide No 2507-RG dated 06.05.2022, after implementation of recommendations of the Shetty Commission, Departmental promotion are to be given to ministerial staff of the Bankura Judgeship with retrospective effect from 01.04.2003.

Accordingly, promotional benefits to the ministerial staff of this Judgeship up to the rank of Bench Clerk Grade III with retrospective effect from 01/04/2003 vide this office Order No 95 dated 06/07/2022 has already been awarded.. 
