In terms of The West Bengal District Court (Constitution of Service, Recruitment, Appointment, Probation and Discipline of Employees) Rules, 2015, in short, Court Rules 2015 issued by the Judicial Department to the Govt. of West Bengal vide letter No 97(9)-JL-JD/L/16M-57/2017 dated 20/07/2021 the eligibility criteria for promotion to the post of Upper Division Clerk as mentioned in SCHEDULE C for Rule 8, 13 and 18 are as under :-

- 75% of vacant posts of Upper Division Clerk are to be filled up by promotion from the Cadre of Lower Division Clerk having minimum of three years of service in the respective cadre.
- 2. Educational Qualification for the post of Upper Division Clerk must be a degree granted by a university established by law in India.
- 3. Remaining 25% of vacant posts of Upper Division Clerk are to be filled by direct recruitment from the candidates, who must be holder of a degree granted by a university established by law in India and must have passed typing test or have such knowledge or qualification in computer operation as may be specified by the High Court at Calcutta from time to time.

The total Nos of Vacant Posts of Upper Division Clerk after 06/07/2021 in the Judgeship of Bankura is 22 (Twenty Two). Accordingly, as per the Court Rules 2015, 75% of vacant posts i.e. 22 X 75% = 16.5 (approx 17) Nos of post of Upper Division Clerk may be filled up by promotion from the lower feeder post i.e. Lower Division Clerk.

Now, in consonance with the recommendations of the Promotional Committee vide resolution dated 02/03/2023, communicated to this office vide letter No 67 dated 02/03/2023, this office Order No 79-A dated 17/06/2022 and the Judicial Department letter No 3444-J/JD/II/16M-29/17 dated 21/08/2018, the undersigned is pleased to award promotion to the following ministerial staff with retrospective date of effect as mentioned against each on regular basis duly maintaining 50 point roster, in the list published hereunder:-
