In compliance of the Judicial Department G.O. No 39-JD/L/2S-23/04(Pt-VI) dated 18/02/2021, G.O. No 5142-J dated 20/07/2009, No 3444-J/ JD/II/16M-29/17 dated 21/08/2018, clarified vide Finance Department Memo No 4550-F(P) dated 11/06/2015 and direction of The Hon'ble High Court, Calcutta vide No 2507-RG dated 06.05.2022, after implementation of recommendations of the Shetty Commission, Departmental promotion are to be given to ministerial staff of the Bankura Judgeship with retrospective effect from 01.04.2003.
