In compliance of the Judicial Department G.O. No 5140-J dated 20/07/2009, clarified vide Finance Department Memo No 5490-F(P) dated 24/10/2016, departmental promotion are to be given to process serving Establishment under the Judgeship of Bankura in the ratio 4:1 of combined strength of Process Server and Seal Bailiff.

At present the Combined Strength of Process Serving establishment under the Judgeship of Bankura is 45. Accordingly 09 Posts i.e. 20% of combined strength of the district should be upgraded and designated as Bailiff in the Judgeship of Bankura. Out of which, 03 posts have already been filled up by departmental promotion and remaining 06 posts of Seal Bailiff in the Judgeship are to be filled up by promotion from the existing strength of process server. Last promotion to the post of Seal Bailiff was given to Sri Sumit Rajak w.e.f. 01/01/2017 as SC Candidate duly maintaining 50 point roster at Sl. No 4 vide this office order No 148 dated 01/07/2019.

Accordingly, Service Books, APR, willingness of employees and confidential reports of concerned Head of Office have been called for vide this office letter No 423(5)/XII-1 dated 06/02/2024. After carefully scrutiny of all the above documents, the undersigned is pleased to award promotion to the following staff in the post of Seal Bailiff with retrospective date of effect as mentioned against each, in the list published hereunder :-
