The candidates are required to type the article that will be given at the time of computer operation and computer typing test containing characters like bold, italics, bullets, paragraph, underline, case, font, superscripts, subscripts, alignments, borders, insertion of table etc. Size of the letter and line spacing shall be specified in the instruction that will be provided before commencement of the test.

Candidates are also required to take print out of the article typed by them.

They must write their particulars like name, designation, present place of posting, and signature on the top of the typing sheet.

Be it mentioned that, the computer operation and computer typing test is optional for the candidates who have attained the age of fifty years and above, as per the memorandum no. $4851-F(H)/F\Lambda/O/2E-1/162/17(N.B.)$ dated 04.08.2017 of the Government of West Bengal Finance (Audit) Department.

Candidates must return the question papers along with their scripts to the examiner. They should take neither the question paper nor the script out of the examination hall. Any failure to this would warrant cancellation of candidature.

The skill test of the members of staff of the Sub-divisional Courts of Khatra & Bishnupur will be taken on 28.02.2024 from 11:00 A.M. and for the members of staff of Bankura Sadar the test will start from 01:00 P.M.

The candidates of the **Sub-Divisional Courts**, **Bishnupur and Khatra** are directed to report before the office of the undersigned on **28.02.2024 at 10:30 A.M.** and the candidates of **Bankura Sadar** are directed to report before the office of the undersigned on **28.02.2024 at 12:30 P.M.**
