In terms of the West Bengal District Court (Constitution of Service, Recruitment, Appointment, Probation and Discipline of Employees) Rules, 2015, in short, Court Rules 2015 issued by the Judicial Department to the Govt. of West Bengal vide letter No 97(9)-JL-JD/L/16M-57/2017 dated 20/07/2021 and in compliance with this office letter No 3501-A/XII-1 dated 18/12/2023, letter No 375(30)/XIII-1 dated 01/02/2024 and No 423(5)/XII-1 dated 06/02/2024, departmental promotion are to be given to the Group D staff and Seal Bailiff/Process Servers in the vacant posts of Lower Division Clerk in the Judgeship of Bankura.

In accordance with the SCHEDULE-C of the Court Rules 2015, 25% Vacant Posts of Lower Division Clerks are to be filled up by promotion from the cadres of Process Server/Summons Bailiff/Seal Bailiff and Attender/Jamedar/other equivalent posts having passed Madhyamik or equivalent in the ratio of 1:2; every third vacancy being filled by promotion of Process Servers/Summons Bailiff/Seal Bailiff/other equivalent posts.

Accordingly, 25% of 55 Nos of total vacant posts of Lower Division Clerks (55X25%= 13.75 = 14 R/o) i.e. 14 Nos of vacant posts of lower Division clerks are to be filled up by promotion from the post of Group D staff and Seal Bailiff/Process servers in the Judgeship of Bankura on seniority-cum-merit basis as per gradation list duly followed existing Govt. Rules/Policies in this regard.

It appears from the office records, that the last promotion to the post of Lower Division Clerk was given to Sri Alok Nath Adhya as Unreserved Candidate duly maintaining 50 point roster at SL No 30 vide Learned District Judge, Bankura Order No 132 dated 20/08/2022 and the said 50 point roster Sl. No. has been considered as the first promotion of Group D staff after implementation of the Court Rules 2015 with effect from 06/07/2021. It is also observed that the Roster Point 28, which was reserved for SC candidate has been carried forward and placed at Sl No 31 due to non-availability of said category.

Now, in consonance with the recommendations of the Selection Committee vide resolution dated 02/03/2024, Court Rules 2015 and The West Bengal Scheduled Castes and Scheduled Tribes (Reservation of vacancies in Services and Posts) Act, 1976 for promotion, the undersigned is pleased to award promotion to the following Group D Staff and Seal Bailiff/Process Servers of this Judgeship with date of effect as mentioned against each, in the list published hereunder :-
