

1. Registration of vehicle must be done as per commercial norms of West Bengal Motor vehicle registration Rule.
2. Maintenance of vehicle will be borne by the vehicle owner.
3. Quotation to be submitted along with a copy of Blue Book.
4. Vehicle along with driver will remain under disposal of the undersigned.
5. Remuneration or allowances of driver will be borne by the vehicle owner.
6. In case of break down or non-availability of the vehicle or the driver, the owner will be bound to arrange substitute vehicle / substitute driver.
7. During opening of the quotations, quotationer may remain present.
8. Contract of vehicle may be terminated as and when necessary.


