Applications in prescribed format are invited from the eligible persons for appointment of one Counselor (in place of Smt. Mamta Sharma due to her non appearance) in Family Court No. 1 of Bharatpur.

1. Qualification

Applicant must possess following qualification as required under Rule 8(2) of Family Court(Rajasthan) Rules 1991 & Amendment Rules, 2016:-

- (i) Degree in Social sciences such as social welfare, sociology, clinical psychiatry, psychology/ philosophy, preferably with a Degree in laws; and
- (ii) At least five years experience in field work/research or of teaching in Government department or in a Collage/university or a comparable academic institute, with special reference to problems of women and children.

or

Five years experience in the examination and/or application of Central/State Laws relating to marriage, divorce, maintenance, guardianship and adoption and other family disputes.

Provide that the High Court may, in exceptional circumstances, relax the minimum academic qualification:

Provide further that preference may be given to women having the requisite qualifications:

Provide also that preference shall be given to a candidate who has been an officer of District Judge cadre or has experience of counseling in family matters.

Applications in prescribed format shall be submitted/Sent to the family court No.1 of Bharatpur for which he/she applying for, latest by 28-10-2022 up to 05.00 P.M. in the office of family court No.1 Bharatpur (Rajasthan). Prescribed format of application



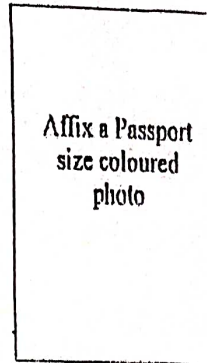
