2. प्रथम छः माह की अवधि में कार्य व्यवहार संतोषप्रद नहीं होने पर किसी भी समय बिना पूर्व सूचना के नवनियुक्त अभ्यर्थी की सेवायें समाप्त की जा सकेंगी।


