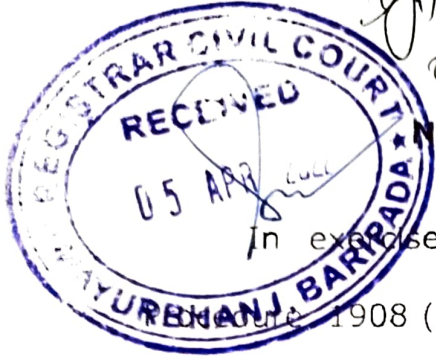
In exercise of the power under-Part-X of the Code of Civil Procedure, 1908 (Act No.5 of 1908) and Clause-(d) of Sub-Section (2) of Section 89 of the said Code, the High Court of Orissa do hereby make the following rules for amendment of the Civil Procedure Mediation Rules, 2007, namely:-

1. These Rule shall be called the Civil procedure Mediation (Amendment) Rules, 2022.
2. They shall come into force on the date of their publication in the Odisha Gazette.
3. In Rule-4 of the Civil Procedure Mediation Rules, 2007, after the Sub-rule (a)(iii), insert the following as Sub-Rule (a)(iv):

4.(a) (iv)- All in-service Judicial Officers irrespective of Cadre.
