- ii. The candidate is to bring Voter ID/ Aadhar/ Driving Licence in support of identity proof and all the **Original Certificates & Marksheets** in support of his/ her Educational, Technical & Skill Qualifications for verification and to get them verified **before the Viva-Voce Test**.
- iii. Candidates are to reach at the Examination Centre before one hour of the scheduled time of examination. They will not be allowed to enter the Examination Centre after the commencement of the examination.
- iv. Candidates are not permitted to leave the Examination Hall before the final bell of the sitting.
- v. Mobile Phone and any other electronic devices are not allowed in the Examination Hall.
- vi. The candidates qualifying in the Shorthand & Type Writing Test will appear in the **Computer Science (Practical) Test on the same day and after qualifying in computer science (practical) Test will appear in the Viva-voce on the same day.**
- vii. The candidates qualifying in Computer Practical Test for the post of Junior Clerk-cum-Copyist will appear in Viva voce Test on the same day.
- viii. The candidates qualifying in Technical Knowledge in Survey & Settlement (Practical) for the post of Salaried Amin will appear in the **Viva voce on the same day.**
- ix. Causing disturbances & adopting malpractice in any form, will entail disqualification.
