'G-1' Dated 31.05.2024** to invite fresh applications for appointment of eligible candidates for the post of Special Judicial Magistrate/Special Metropolitan Magistrate.

In this regard Applications are invited from eligible candidates who have eligibility as mentioned in Section-13 of Cr.p.c. 1973 upto 29.06.2024. Candidates may apply who holds or has held any post under the government and possesses the degree of law or otherwise is well experienced in relation to the legal affairs. All the applications must be submitted on prescribed proforma hear in after attached with this notice with their character roll entries of last five years and self attested xerox copies of documents of the particulars mentioned in the application. A person shall be qualified for appointment as A Special Judicial Magistrate if he/she has hold or held any post under the Government; and possesses the degree of law or otherwise is well experienced in relation to legal affairs to the satisfaction of the High Court. The terms of the office as Special Judicial Magistrate/Special Metropolitan Magistrate shall be four years from the date of assumption of his charge or attaining the age of 70 years whichever is earlier.

**Qualification:** A person **shall not be qualified** for appointment as a Special Judicial Magistrate **unless** he/she:-

- (a) holds or has held any post under the Government; and
- (b) possesses the degree of law or otherwise is well experienced in relation to legal affairs to the satisfaction of the High Court.

**Term of Office:** The term of the office as Special Judicial Magistrate/Special Metropolitan Magistrate shall be four years from the date of assumption of his charge or attaining the age of 70 years whichever is earlier.

**Documents required with application:** All the applicants shall submit their applications containing self-attested xerox copies of the documents of the particulars mentioned in the application alongwith the photocopies of character roll entries of the last 5 years of their Government Job.

**Submission of Form:** All the applicants shall submit their applications alongwith all the relevant documents to the District Court(s) of the district(s) for which they are applying for the post of SJM/SMM. The District Judge(s) after proper scrutiny shall only forward those applications to the High Court which he finds fit for the post of SJM/SMM alongwith his remarks without any delay.
