

**INSTRUCTIONS**

1. The District Judge, Prayagraj invites the sealed tender from the interested firms for sale of unusable, outdated and faulty Computer and other related equipments, lying in District Court.
2. Tender once submitted can not be withdrawn.
3. Bidders are required to submit tenders for the items mentioned **Table'A'**. Bids submitted for part of the items of the **Table'A'** shall not be considered.
4. The interested firms may submit their sealed tender in attached proforma along with **Earnest Money Deposit of ₹ ₹18,000.00** through Demand Draft in favour of District Judge, Prayagraj. Any bid not accompanied by an acceptable Earnest Money, shall be rejected.
5. Sealed tenders addressed to "District Judge, Prayagraj" in attached proforma must reach Computer Centre of District Court, Prayagraj **latest by 04<sup>th</sup> January, 2025 upto 1.30 p.m.**, Any tender received by the Computer Centre after the deadline prescribed in tender document will be returned unopened to the firm.
6. Quantity/items fixed for selling as mentioned in Notice may increase or decrease or change as per discretion of the Auction Committee.
7. Before the deadline for submission of tender, the Auction Committee may modify the tender documents by issuing addenda. Any addendum thus issued shall be part of the tender documents and same shall be published in the official web-site of this Judgeship and Hon'ble High Court.
8. Each page of the tender shall be typed or written in indelible ink and shall be signed by the representative duly authorized to sign on behalf of the firm.
9. The tender shall contain no overwriting, alterations or additions, except those to comply with the instructions issued by the Auction Committee.
10. The Earnest Money of unsuccessful tenderers will be returned at the earliest after the finalization of successful firm.
11. The Earnest Money of successful firm will be adjusted against the overall tender amount.
12. The tenders received will be opened at the time, date and place specified in the tender document.
13. The Judgeship will award the contract to the firm whose tender has to be determined to be substantially responsive to the the tender documents and who has offered the highest tender price for the purchase of items.
14. Notwithstanding the above clause, the Auction Committee reserve the right to accept or reject any tender, to extend the date of submission & opening if sufficient no. of bids are not received, to cancel the tender process or to reject all tenders.
15. The firm whose tender has been accepted will be informed by letter. The bidder has to deposit this requisite amount with the period of 07 days after the receipt of letter of acceptance thereafter firm will be allowed to take away the items deemed sold.
16. The successful bidder shall deposit requisite amount within 07 days from the date of acceptance letter failing which the committee shall cancel the tender and forfeit the Earnest Money deposited.
17. All applicable taxes, if any admissible rate, has to be paid by the successful tenderer.
