**NOTICE**

Due to non-joining of Sri Prakash Chandra Tripathi on the post of Special Judicial Magistrate, Prayagraj, the Hon'ble High Court Allahabad has directed through letter no-10474/2026/SJM/Admin 'G-1'/Allahabad Dated 14.08.2026 to invite fresh applications for appointment of eligible candidates for the post of Special Judicial Magistrate.

In this regard, Applications are invited from eligible candidates who have eligibility as mentioned in Section 11 of the BNSS (who holds or has held any post under the government and possesses the degree of law or otherwise is well experienced in relation to the legal affairs) **upto 17.10.2026**. All the applications must be submitted on prescribed proforma hear in after attached with this notice, along with their self-attested certificates and character roll entries of last five years. Certificates and character roll entries will not be required for ex-SJMs appointed by the State of U.P.; however best four judgements of ex-SJMs will be required. A person shall be qualified for appointment as a Special Judicial Magistrate if he/she has hold or held any post under the Government; and possesses the degree of law or otherwise is well experienced in relation to legal affairs to the satisfaction of the High Court. The terms of the office as Special Judicial Magistrate/Special Metropolitan Magistrate shall be four years from the date of assumption of his charge or attaining the age of 70 years whichever is earlier.

In-charge Nazarat of District Court Prayagraj is requested to publish this notice in one National Newspapers and one Regional Newspapers within three days.

In-charge Computer of District Court, Prayagraj is requested to upload this notice on official website of District Court Prayagraj and send copy to Hon'ble High Court for uploading on official website of Hon'ble High Court.

Central Nazir of District Court, Prayagraj is directed to publish this notice on notice board of Nazarat and All Bar Associations of District Court, Prayagraj.

### Instructions

**1. Qualification:** A person shall not be qualified for appointment as a Special Judicial Magistrate unless he/she:-

- (a) holds or has held any post under the Government; and
- (b) possesses the degree of law or otherwise is well experienced in relation to legal affairs to the satisfaction of the High Court.

**2. Term of Office:** The term of the office as Special Judicial Magistrate shall be four years from the date of assumption of his charge or attaining the age of 70 years whichever is earlier.

**3. Documents required with application:** All the applicants shall submit their applications containing self-attested photocopies of the documents of the particulars mentioned in the application along with the self-attested photocopies of character roll entries of the last 5 years of their Government Job. Character roll entries will not be required for ex-SJMs appointed by Government of Uttar Pradesh; however, if an ex-SJM is applying for re-appointment, he will enclose four best judgments delivered while holding the post of SJM/SMM.

**4. Submission of Form:** All the applicants shall submit their application along with all the relevant documents to the District Judge of the district for which they are applying for the post of SJM, and not directly to the High Court. The application which is sent directly to the High Court shall stand rejected and shall not be processed further.

**5. Scrutiny of Form:** The District Judge(s), after proper scrutiny, shall, without any delay, forward only those applications to the High Court which he finds fit for the post of SJM along with his remarks.

**6.** A candidate, having been duly selected for and appointed in a specific district, shall not, under any circumstances, be transferred to any other district.
