The Principal District and Sessions Judge, Khammam is pleased to pass the following order on Administrative grounds with immediate effect.

Sri Mekala Kamalakar Rao who expired on 04.09.2022 while working as Chief Administrative Officer in the Court of the Principal District Court, Hanumakonda. Therefore, the following appointment on compassionate grounds is made to his daughter Smt. Mekala Priyanka after following the procedure laid down under the Government Orders issued from time to time.

Smt. Mekala Priyanka, D/o Late Kamalakar Rao, R/o H.No. 16-3-160/7, Flat. 410, Mythri Apartment, Gollagudem, Velugumatla Village, Khammam Urban Mandal, Khammam District is temporarily appointed as **Junior Assistant**, at **Roster Point No.11 (O.C.)** in 100-Cycle-I in the existing Time Scale of Pay **24280-72850** and posted as Junior Assistant in the Court of **VI Additional District and Sessions Judge, Sathupally** in the existing vacancy.

The appointment of Smt. Mekala Priyanka, D/o Late Kamalakar Rao as Junior Assistant is purely on temporary basis and she is liable to be terminated at any time without assigning any reason or notice.

Smt. Mekala Priyanka, D/o Late Kamalakar Rao **shall report duty within one month on receipt of this proceedings**, failing which her appointment order will be cancelled.

The individual is directed to submit Physical Fitness Certificate issued by not below the rank of Civil Surgeon or a District Medical Officer and (02) sets of attested copies of qualification certificates, study certificates etc., along with the joining report at the time of reporting to duty.
