NOTIFICATION

Applications (in Triplicate) are invited from the eligible candidates to fill up the following posts in the prescribed format enclosed herewith.

- (i) 2<sup>nd</sup> Special Judicial Magistrate of II Class, Khammam
- (ii) Special Judicial Magistrate of II Class (Excise), Khammam
- (iii) Special Judicial Magistrate of II Class (Railways), Khammam

Last date to receive the applications: **10.04.2023** till 5.00 p.m., the applications received after last date will be rejected.

The Applications shall be submitted through Registered post (OR) Courier to the Prl. District and Sessions Judge, Khammam

The term of the post of Special Judicial Magistrate of II Class is two years and shall be paid Honorarium of Rs.15,000/- per month.

I. QUALIFICATIONS:-

**A PERSON**

1. Who has held a post in the Telangana Judicial Ministerial and Subordinate Services not below the rank of Superintendent of District Court or Senior Civil Judge or Junior Civil Judge's Court and having law degree; OR
3. Who has held a post of Section officer and above in the Telangana High Court Services and having Law Degree; OR
4. A non-practicing Advocate with a practice at the Bar of not less than five years and who is above 45 years of age **should file a Certificate of voluntary suspension of practice issued by the Bar Council of state of Andhra Pradesh or Telangana;** OR
5. Any retired Gazetted officer possessing Law Degree OR who has passed the Criminal Judicial Test ( Full test consisting of Indian Penal Code ;and the Criminal Judicial Test ( Full test consisting of Indian Penal Code and the Code of Criminal Procedure) conducted by the Andhra Pradesh Public Service Commission/ Telangana Public Service Commission and who has exercised magisterial posers during his tenure of service for not less than three years.
6. And who has at least one year to complete 65 years of age at the date fixed by the Court in the year of recruitment shall alone be eligible.





Provided that a suitable retired Judicial Officer shall be preferred.

## II. DISQUALIFICATIONS:

### **A PERSON**

1. Who is a practicing Advocate, OR
2. Who is a member of any State or Local Authority; OR
3. Who is a member of the State Legislature or of the Parliament OR
4. A person who having held an Officer under the state or the Union Government or any Local Authority, has been dismissed or removed or compulsorily retired from service or subjected to any other major penalty for misconduct, OR
5. A person who has been convicted and sentenced by a court for an offence involving moral delinquency or is charged of any offence constituting moral turpitude and proceedings are pending, OR
6. A person unsound mind or who is deaf or mute or blind or suffering from Leprosy or any other contagious disease OR
7. A person adjudicated as insolvent or an undercharged insolvent, OR
8. A contract or a businessman or one interested in a subsisting contract or any work being done for Central or State Government or a Local Authority within whose limits the Special Magistrate has to discharge his duties, shall not be eligible.


## III REVOCATION OF POWERS OF SPECIAL MAGISTRATES:-

1. On appointment and while in service a Special Judicial Magistrate of II Class or Special Magistrate of any other category may be removed without being called upon to show cause if he fails to attend three consecutive sittings of the Court without a written permission of the Chief Judicial Magistrate or the Chief Metropolitan Magistrate, as the case may be.
2. Powers conferred by the Court on Special Judicial Magistrate of II Class or Special Magistrate of any other category shall automatically stand withdrawn on his attaining the age of 65 years.

## IV GENERAL INSTRUCTIONS:

1. As per the Hon'ble High Court Circular ROC.No. 802/SO/97, dt, 29.01.1998 the Spl. Judl. Magistrate of Second Class Courts are functioning for (05) days in a week i.e from Monday to Friday on working days between 7.30 a.m. and 10.30 a.m.
2. The appointing Authority reserves the right to cancel the notification without assigning any reason thereof.
3. No T.A. will be paid for candidate for journey performed in connection with recruitment.
4. All the necessary copies of documents such as, qualification certificates, retirement proceedings, etc., applications do not contain necessary enclosures as detailed above will be rejected.

5. Applications with insufficient information will be summarily rejected.
6. The applications submitted in a sealed cover with superscribing the name of the post on the cover.
