Persons selected have to produce Fitness Certificate and enter into an Agreement/Contract with the Principal District and Sessions Judge, Khammam on such terms and conditions as the appointing authority deems fit, proper and necessary regarding the conditions of appointment and service and on all other required particulars.
- The candidates are directed to produce a copy of Retirement proceedings issued by the concerned District Judge or copy of the Pension Payment Order(PPO) isssued by the competent authority.

- The candidates will be appointed only on Contract basis as per Rule-9 of Telangana State and Subordinate Service Rules, 1996 for a period up to **31.03.2025** or on attaining the age of 65 years or the date fixed by the appointing authority from time to time on executing a Deed of agreement at the time of making their appointment.
