NOTIFICATION

Applications are invited from the retired judicial employees from the category of Chief Administrative Officer/ Senior Superintendent upto 5.00 pm on **03.05.2025** to fill up the post of **Senior Superintendent (Head Clerk) contract basis** on consolidated remuneration of **Rs.40,000/-** per month, **for a period upto 31.03.2026** or on attaining the age of 65 years, in the court of Second Fast Track Special Courts for expeditious trial and disposal of cases of rape and protection of children against sexual offences (POCSO) Act, Khammam.

The applications shall be sent in a sealed cover addressed to the **PRINCIPAL DISTRICT AND SESSIONS JUDGE, KHAMMAM**, by mentioning for which post applied and sent the same by way of post or by way of courier and **the application forms will not be entertained either directly or in person.**

I. CONDITIONS

1. The individual must not have completed **65 years** of age as on the date of notification.
2. Only persons who have retired as member of Telangana Judicial Ministerial Services alone will be considered.
3. Only persons who are of sound health and active habits alone will be considered
4. Persons with proven record of ability, good performance and integrity alone will be considered
5. Persons selected have to produce Fitness Certificate and enter into an Agreement/Contract with the Principal District and Sessions Judge, Khammam on such terms and conditions as the appointing authority deems fit, proper and necessary regarding the conditions of appointment and service and on all other required particulars.
6. The candidates are directed to produce a copy of Retirement proceedings issued by the concerned District Judge or copy of the Pension Payment Order(PPO) issued by the competent authority.

GENERAL INSTRUCTIONS:

- 1 The candidates will be appointed only on Contract basis as per Rule-9 of Telangana State and Subordinate Service Rules, 1996 for a period up to **31.03.2025** or on attaining the age of 65 years or the date fixed by the appointing authority from time to time on executing a Deed of agreement at the time of making their appointment.
- 2 The monthly remuneration shown above shall be in addition to the terminal benefits from his previous employment
- 3 The provisions contained in Telangana civil Service(Conduct) Rules, 1964 and Telangana Pension code shall be applicable mutates mutandis.
- 4 No other service rules shall be applicable other than noted above
- 5 The contract appointment shall automatically ceases to be in operation unless a fresh proposal is made and fresh contract is entered into
- 6 No TA and DA will be paid for the journey performed in connection with the appointment
- 7 Applications with insufficient information will be summarily rejected
- 8 Application received after the date stipulated would not be accepted
- 9 No correspondence will be entertained in any respect
- 10 Candidates resorting to bring influence of any kind will be disqualified summarily
