It is notified for the information of all concerned that:

- ❖ All the Applicants are requested to present 15 minutes earlier for the Interview.
- ❖ No individual interview call letter will be sent by post to any candidate whose name figures in the said list and the candidate(s) shall have to

download the list from <https://coimbatore.dcourts.gov.in> website and appear before the interview committee on the scheduled date and time.

- ❖ Failure of an Applicant to appear for the interview on the given date and time shall forfeit his/her right of consideration.
- ❖ In case any deficiency with reference to eligibility etc., is found at the time of interview, the applicant concerned shall not be allowed to appear in the interview, and if any deficiency is found subsequently, the candidate concerned shall not be considered for selection and he/she shall be treated as disqualified.
- ❖ The Applicants shall have to produce all original certificates/testimonials before the selection committee at the time of interview. A candidate who fails to produce such certificates / testimonials may forfeit his/her candidature.
- ❖ The posts are purely contract basis and the duration is only for 2 years which may be extended based on the performance with periodical breaks as per the guideline of NALSA Legal Aid Defense Counsel System. The selected candidates cannot claim for permanency of the job.
- ❖ The selection criteria will be as per the guidelines of NALSA- Legal Aid Defense Counsel System under Modified Scheme, 2022.
