Sub: Matter regarding revision of various allowances pertaining to the serving/retired Judicial Officers as recommended by Second National Judicial Pay Commission as per Judgement/ Order dated 04.01,2024 passed by Hon'ble the Apex court in Writ Petition (Civil) No. 643 of 2015 titled All India Judges Association Vs Union of India and Others.

Sir,

With due reverence, it is to inform you that in compliance of order dated 04.01.2024 of Hon'ble Apex Court passed in above cited Judgement Hon'ble the Committee has been constituted vide order dated 12.01.2024 of Hon'ble the Acting Chief Justice for overseeing the implementation of various allowances to the Judicial Officers as well as retired Judicial Officers on the basis of recommendations made by the Second National Judicial Pay Commission (SNJPC).

Under the directions of Hon'ble the Committee, it is to inform you that the compliance of below-mentioned directions / resolutions of Hon'ble the Committee, are required:

1. A Nodal Agency/Nodal Officer at the Level of District Judgeship, to handle the disbursement of allowances, arrears, services, retiral benefits, and grievances for Judicial





officers is to be appointed as well as grievances of Judicial officers in this regard in view to ensure a focused and efficient approach for managing financial and administrative aspects.

- 2. Further, the Concerned District Judgeship including District Courts, Family Courts. Commercial Courts, MACT, LARRA is to be the Nodal Agency at the Level of District Judgeship. Nodal Officer of the aforesaid Nodal Agency will be either concerned District & Sessions Judge or Judicial Officer of H.J.S. Cadre as nominated by District & Sessions Judge (preferably D.D.Os). The Nodal Agency/Nodal Officer at the Level of District Judgeship will look into the matter of redressal of grievances relating to disbursement of allowances, arrears and other services of Judicial Officers /retired Judicial Officers /Family Pensioners of Judicial Officers. In the event grievance, if any, remains unresolved at the District Level, the concerned Nodal Agency/Nodal Officer will forward the same to the Hon'ble High Court.
- 3. Nodal Officers at the Level of District Judgeship are also instructed to maintain a database of Retired Judges and Family Pensioners in the District Judgeship. This database should undergo periodic updates, at least quarterly, in accordance with the directions contained in the Judgment dated 04.01.2024 of Hon'ble Apex Court, and the same be sent to Hon'ble High Court.
- 4. The Nodal Agency and Nodal Officer at the Level of District Judgeship should furnish contact details, such as mobile numbers and email addresses, to the Hon'ble High Court at the earliest, so that these details may be subsequently uploaded on the concerned District Court's websites as well as Hon'ble High Court's website for easy accessibility.

In view of above, your goodself is requested to kindly take necessary action at your end in view to ensure the necessary compliance at the earliest and provide a compliance report so that the same may be placed before the Hon'ble Committee.
