G.S.R.31 .-In exercise of the powers conferred by Sub-Section (1) of Section 28 of the Right to Information Act, 2005 the Chief Justice of Rajasthan High Court (Competent Authority) hereby makes following amendments in "Rajasthan Right to Information (High Court and Subordinate Courts) Rules, 2006", as under:-

- 1. Short Title and Commencement. (1) These Rules shall be called "Rajasthan Right to Information (High Court and Subordinate Courts) (Amendment) Rules, 2023".
  - (2) These amendments shall come into force from the date of their publication in the Official Gazette.
- 2. Amendment in Rule 4.- Following amendments shall be made in Rajasthan Right to Information (High Court and Subordinate Courts) Rules, 2006 (hereinafter referred as 'the said Rules'):-
  - (i) In sub-rule (1) of Rule 4 the punctuation ":" shall be substituted by "." and after the expression "non refundable:" following shall be inserted:-
  - "Application can also be made online, by paying required fee, through the web portal of Rajasthan High Court."
  - (ii) In sub-rule (2) of Rule 4 after the expression "appendix-AB." following shall be inserted:-
  - "Acknowledgment of Online Application may be provided online / by SMS."
- 3. Amendment in Rule 5.- Following amendments shall be made in the Rule:-
  - (i) In sub-rule (1) of Rule 5, the expression "online/offline (as per the nature of application)" shall be inserted in between the expressions "shall be informed" and "in Form-C".

- (ii) In sub-rule (2) of Rule 5, the expression "online/offline (as per the nature of application)" shall be inserted in between the expressions "rejection order" and "in Form D".
- (iii) In sub-rule (3) of Rule 5, the expression "online/offline (as per the nature of application)" shall be inserted in between the expressions "shall be informed" and "about such transfer" and in between the expressions "He shall convey it" and "in form 'E".
- (iv) In sub-rule (4) of Rule 5, the expression "online/offline (as per the nature of application)" shall be inserted in between the expressions "shall be supplied" and "as early as practicable".
- (v) In sub-rule (5) of Rule 5, following amendments shall be made:-
  - (a) in sub-rule (5)(i), the expression "or Scanned Copy" shall be inserted in between the expressions "True Copy" and "of the document".
  - (b) in sub-rule (5)(ii), the existing expression "electronic media" and "appellant" shall be substituted by the expression "electronic mode" and "applicant", respectively and the expression "online/offline (as per the nature of application)" shall be inserted in between the expressions "deficiency good" and "within next 5 days".
  - (c) Following new sub-rule (5)(iv) shall be inserted:-
    - "(iv) Form B, C, D & E and documents to be provided online can be digitally signed by the authorized person".
- **4. Amendment in Rule 7.**-Following amendments shall be made in the existing Rule 7 of the said Rules:-
  - (i) In sub-rule (1)(b) of Rule 7, the expression "online/offline" shall be inserted in between the expressions "an appeal" and "in Form 'G".
  - (ii) In sub-rule (2) of Rule 7, the expression "online/offline (as per the nature of appeal)" shall be inserted in between the expressions "be acknowledged" and "and after giving".
  - (iii) In sub-rule (3) of Rule 7, the expression "online/offline (as per the nature of appeal)" shall be inserted in between "additional information" and "to the applicant".
- 5. Amendment in Rule 9.- Following new sub-rule (1A) shall be inserted in Rule 9 of the said Rules:-
  - "(1A):- The application for inspection of record may be made online by paying requisite fee through web portal of Rajasthan High Court. In case of refusal of

such application copy of refusal order may be sent online. Additional payment may be made online in accordance with sub-rule (1)".

6. Existing Rule 11 "Online application" of the said Rules shall be deleted.

- 7. Amendment in Form 'A'.- In para 5 of the Form 'A' of the said Rules, after the expression "Postal order" the word "or online receipt" shall be inserted.
- **8. Amendment in Form 'B'.-** In para 3 of the Form 'B' of the said Rules, after the expression "notice board" the word "/web portal" shall be inserted.
