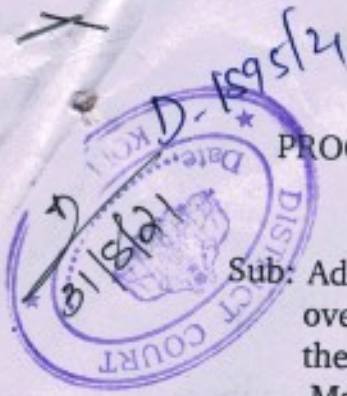

PROCEEDINGS OF THE CHIEF JUDICIAL MAGISTRATE, KOLLAM  
Present: Sri. Prasun Mohan, Chief Judicial Magistrate.

Sub: Administration of Justice - Transfer of Cases - Withdrawal and making over of 500 number of cases from the Court of Judicial Magistrate of the 1<sup>st</sup> Class - III, Kollam to the file of the Court of Hony.Spl.Judl. II Class Magistrate(for Petty Offences), Kollam - Reg.

Read: 1. OM No. D - 1408/21 of this Court.  
2. Lr. No. 490/21 dated 16/07/21 of the Court of Judicial I Class Magistrate - III, Kollam.

**ORDER No. T - 3768/2021 Dated 26/08/21**

In pursuance to the 1<sup>st</sup> reference read above, it was decided to withdraw 500 cases from the Court of Judicial Magistrate of the 1<sup>st</sup> Class - III, Kollam and making over the same to the Court of Hony. Spl. Judl. II Class Magistrate(for Petty Offences), Kollam u/s 410 CrPC to balance the work load and pendency in both Courts. Consequent to the 1<sup>st</sup> reference read above, the Judicial Magistrate of the 1<sup>st</sup> Class - III, Kollam vide 2<sup>nd</sup> reference read above forwarded a list of 500 cases vide **Annexure - A List.**


Hence it is ordered to accord sanction to withdraw the 500 number of cases in the Annexure - A of this order from the file of the Court of the Judicial Magistrate of the 1<sup>st</sup> Class - III, Kollam and making over the said cases to the file of the Court of Hony. Spl. Judl. II Class Magistrate(for Petty Offences), Kollam for trial and disposal in accordance with the law by complying the following directions.

1. List of cases transferred from transferor to transferee Court shall be published in the notice board of transferor and transferee Court and a copy of the list should be forwarded to the president/Secretary of Bar Association and Advocate Clerk Association of Kollam for being published in the notice board of the Bar Association or Advocate Clerk Association.



2. The transferred cases should not be included by the transferor Court as "disposal" in the Monthly Statement of cases and instead it should be mentioned as "transferred" in the disposal column of the statement.
3. Transferred cases should not be included in the list of "targetted cases" in the target period of 2021 – 2022.
4. The transferee Court shall take the cases on file as per law and they must file a compliance report to this Court. Both the transferor and transferee Court shall complete the procedures of transfer of cases at the earliest and report compliance.
5. Transferred cases shall be shown as "transferred" in CIS(Case Information System).
