#### I. Organisation, functions and duties

- (a) Special Court for SC/ST(POA) Act Cases, and Additional Sessions Court, Kottarakkara is invested with Criminal matters of Scheduled Caste/ Scheduled Tribes (prevention of Atrocities) Act Cases and Abkari Act Cases.
- (b) The administrative wing consist of Sheristadar-1, Junior Superintendent-1, Bench Clerk Grade 1-1, Clerks-3, Confidential Assistant-1, Typist-2, Office Attendant-3, Daffedar-1, Part Time Sweeper-1 Total-14.
- (c) The functions and duties of Special Court for SC/ST(POA) Act Cases, Kottarakkara is primarily based on administration of Justice in its jurisdiction.

#### II. The powers and duties of officers and employees

The Special Court Kottarakkara exercises jurisdiction on criminal matters arising Atrocities against Scheduled Castes/ Scheduled Tribes in the District. On the judicial side, its duty is to receive and dispose the cases and matters pertaining to the administration of justice and in the administrative side, that are as prescribed in the Manual of Office procedure, Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, various Rules of Practices, Service Rules, etc.

### III. The procedure followed in the decision making process, including channels of supervision and accountability

- (a) In the judicial side, proceedings are channeled through Judicial Service Centre-> Sheristadar-> Court Fees/Inward Section Clerk-> Bench Clerk-> Judicial Officer.
- (b) In the administrative side, files are channeled through Clerks/Junior Superintendents-> Sheristadar -> Judicial Officer.

#### IV. The norms set for the discharge of functions

The functions of this Court is discharged in accordance with the various rules and regulations constituted for the purpose. Issues are dealt with on priority basis, expeditiously taking in to account, the various instructions issued from superior courts from time to time.
