Kollam Judiciary at a Glance

To hear complaints regarding Revenue matters, a new court was formed in Kollam. It was in 1832, a Munsiff Court started functioning here. Along with that a District Court was also introduced for the trial of Criminal Cases. 'Chatta Variyola' (Rules of Practice) known as 'Travancore Rules' established in 1836 came into effect in Kollam also. A post of Second Additional District Judge was created in District Court, Kollam in 1908 and in consequence the Munsiff Court was renovated . The Grama Panchayath Courts came into effect in 1910.

The District court has appellate jurisdiction over all subordinate courts situated in the district on both civil and criminal matters. Subordinate courts, on the civil side (in ascending order) are, Junior Civil Judge Court, Principal Junior Civil Judge Court, Senior Civil Judge Court (also called sub-court). Subordinate courts, on the criminal side (in ascending order) are, Second Class Judicial Magistrate Court, First Class Judicial Magistrate Court, Chief Judicial Magistrate Court. The Munsiff Courts deal with civil cases up to the valuation of Rs.10 Lakhs and Sub Courts deal with civil cases above the valuation of Rs.10 lakhs.
