- (ii) who has held a post in the A.P.Judicial Ministerial Service not below the rank of Head Clerk of District Munsif's Court now re-designated as Superintendents and has a Law Degree, retired or resigned (OR)
- (iii) who has held a post of Section Officer and above in the A.P. High Court Service and has a Law Degree, retired or resigned (OR)
- (iv) a non-practicing Advocate with a practice at the Bar of not less than five years and who is above 45 years of age (OR)
- (v) any retired Gazetted Officer possessing Law Degree or who has passed the Criminal Judicial Test (Full test consisting of the Indian Penal Code and the Code of Criminal Procedure) conducted by the A.P. Public Service Commission and who has exercised Magisterial powers during his tenure of service for not less than 3 years (AND)
- (vi) who has at least one year to complete 65 years of age at the date fixed by the Court in the year of recruitment shall alone be eligible.

A suitable retired Judicial Officer will be given preference.

# V. **DISQUALIFICATIONS:**

- (i) who is practicing advocate; OR
- (ii)who is a Member of any State or Local Authority; OR
- (iii) who is a Member of the State Legislature or of the Parliament; OR
- (iv) a person who having held an Officer under the State or the Union Government or any Local Authority has been dismissed or removed or compulsorily retired from service or subjected to any other major penalty for misconduct; OR
- (v) a person who has been convicted and sentenced by a court for an offence involving moral delinquency or is charged of any offence constituting moral turpitude and proceedings are pending; OR
- (vi) a person of unsound mind or who is deaf or mute or blind or suffering from leprosy or any other contagious diseases; OR
- (vii) a person adjudicated as an insolvent or an undischarged insolvent; OR
- (viii) a contractor or a businessman or one interested in subsisting contract or any work being done for Central or State Government or a Local Authority within whose limits the Special Judicial Magistrate of Second Class has to discharge his duties;

are not eligible.

# VI. REVOCATION OF POWERS OF SPECIAL MAGISTRATES:

- (i) On appointment and while in service a Special Judicial Magistrate of Second Class will be removed without being called upon to show cause if he failed to attend five consecutive sittings of the Court without a written permission of the Chief Judicial Magistrate.
- (ii) Powers conferred by the Court on Spl. Judicial Magistrate of Second Class shall automatically stand withdrawn on his attaining the age of 65 years.
