NOTE:

- 1) The above individuals are informed that their appointments to the post of Junior Assistant under A.P.J.M.S.S. Rules, 2019, are **temporary**, **subject to verification of antecedents of the candidates**. If the antecedents of the candidates are found to be adverse, such candidates will be removed or dismissed from service without serving any notice.
- 2) The candidates shall join the duty on or before **08.05.2023**, by reporting before the Presiding Officers of concerned Courts.
- 3) If the documents/certificates produced by the candidates are found to be have been created, manipulated, interpolated or forged in future date, such candidates would be removed/dismissed from the service besides launching criminal prosecution against them.
- 4) The candidates shall execute a Personal Security Bond at the time of joining (in the prescribed proforma, enclosed) in favour of the Principal District Judge, Ananthapuramu for a sum of Rs.5 lakhs, agreeing to serve the Prl. District Court, Ananthapuramu for a minimum period of 2 years.
 - The concerned Presiding Officers are directed to invariably obtain the Personal Security Bond from the candidates and forward them to Prl. District Court, Ananthapuramu, without fail.
- 5) The candidates shall deposit Rs.10,000/- (Rupees ten thousand only) as security within one month from the date of joining, by way of Term deposit, for the due and faithful performance of duties, as prescribed under Rule 22 of APJMSS Rules, 2019, failing which their probation will be deemed to have been terminated and they will be discharged from the service. The concerned Presiding Officers are directed to obtain the Term Deposits and forward them
- to Prl. District Court, Ananthapuramu.

 6) The candidates shall produce Physical Fitness certificate issued by the Government Medical Officer, not below the rank of Civil Assistant Surgeon at the time of joining duty.
- 7) Appointment of the above candidates is covered by "CONTRIBUTORY PENSON SCHEME" as per G.O.Ms.No.653, 654 and 655, Finance (Pension-1) Department, dated 22.09.2004, issued by the Government of Andhra Pradesh.
- 8) The candidates, who are already in any Government Service, shall resign it and then join the present post.
- 7) The concerned Presiding Officers are directed to intimate the dates of joining and whether the candidates have joined or not, without any delay.
