ORDER A.No.110/2024:

Upon selection of candidates held on 19.10.2024 under the Notification cited at 3<sup>rd</sup> reference, the following order is passed:

- 2) Sri **YELAMAKURU SHIVA**, S/o Sri Y.Venkataswamy, D.No.1-127, Konakondla Village, Vajrakarur (M), Ananthapuramu District (Cell Ph: 9963085778) (**Date of Birth: 30.06.1991**) is appointed as Office Subordinate (Attender), **on contract basis**, and posted as Office Subordinate (Attender), II Spl. Magistrate Court, Ananthapuramu, in the existing vacancy.

These orders shall come into force with immediate effect.


Note:

1. The individuals shall execute agreement of contract in the prescribed proforma before joining duty, for a period from the date of joining till the term of the Court is expired or completion of age of **70** years of the individual, or till termination of contract for any other reason, whichever is earlier.
2. The above appointments made on contract basis are purely temporary and liable to be terminated as per terms of contract.
3. The individuals will be paid consolidated monthly remuneration of **Rs.20,000/-** as per extant rules (i.e. Minimum of time scale of Revised Pay Scales-2022), which may vary from time to time as per the Government Orders that may be issued from time to time.

4. The individuals are directed to produce medical fitness certificate issued by the Doctor not below the rank of Civil Assistant Surgeon at the time of joining.
5. The individuals are directed to join the duty within **15** days from the date of receipt of this order.
