- 1) The candidates are hereby informed that the appointment to the post of Court Attendant is for a period of 2 years. If the work of the appointees is satisfactory they may be considered for re-appointment for subsequent period.
- 2) The services are liable to be terminated at any time without assigning any reason or notice and in no case will they be continued beyond 65 years of age. The appointment is purely temporary and on honorarium basis.
- 3) They shall produce medical fitness certificate at the time of joining duty.
- 4) Consolidated Honorarium for the post of Court Attendant is Rs.6,000/- p.m. as per G.O. cited at 2<sup>nd</sup> reference.
- 5) The candidates shall join duty within 7 days from the date of receipt of this order.
- 6) This order shall come into force with immediate effect.
