Upon selection of candidates held on 02.11.2024 under the Notification cited at 3rd reference, the following order is passed:



Further, she is directed to work on deputation in Prl. Civil Judge's Court (Junior Division), Hindupur, until further orders.

Note:

- 1) The candidate is hereby informed that the appointment to the post of Court Assistant is for a period of 2 years. If the work of the appointee is satisfactory she may be considered for re-appointment for subsequent period.
- 2) She is liable to be terminated at any time without assigning any reason or notice and in no case will she be continued beyond 65 years of age. The appointments are purely temporary and on honorarium basis.
- 3) She shall produce medical fitness certificate at the time of joining duty.
- 4) Consolidated Honorarium for the post of Court Assistant is Rs.10,000/- p.m. as per G.O. cited at 2nd reference.
- 5) The candidate shall join duty within 7 days from the date of receipt of this order.
- 6) This order shall come into force with immediate effect.
