Dear Sir/Madam,

**SUB:-High Court – Computer Section** – New Computer Codes to certain categories of cases which were not allotted a separate Computer Code – Circulation of the Computer Codes to all the Court Establishments in the State of Andhra Pradesh for utilizing in STAT HUB Application to send the monthly statistics from the trail Court to Principal District Court and Principal District Court to High Court – Regarding.

I invite your attention to the subject and reference cited above.

As directed, I am to state that the High Court issued a circular in the reference cited communicating the method of assessment of work of the Judicial Officers with revised circular instructions. I am to further state that the High Court issued Computer Codes to certain category of cases for the purpose of assessment of the units secured by the Judicial Officers and all the Judicial Officers and OP Cells under the control of Principal District Judges have been using the Computer Codes while sending the periodical statements to the High Court.

I am to further state that Computer Section took steps for development of web Application viz., STAT HUB for sending the monthly statements to the High Court as per the instructions of the Hon'ble Computer Committee and it has been tested from the month of May, 2024 with real time statistics. During the process of testing the Application, High Court received oral requests from the OP Cells of the District Courts that there are no Computer Codes to certain category of cases and as such, the OP Cells are unable to distinguish many categories of cases and requested the Registry to

create Computer Codes for certain category of cases enabling all the Courts to push the statistics duly calling the categories of cases with a separate Computer Code and enabling all the Courts to generate the statements basing on particular Computer Code or multiple Computer Codes. The existing Computer Codes and new Computer Codes are being shared herewith for the purpose of utilizing the old and new Computer Codes in the STAT HUB Application.

Therefore, I request your goodselves to instruct all the Courts under your control to utilize new Computer Codes as well as old Computer Codes for the purpose of filling the data in STAT HUB Application and to send a monthly statements to the Principal District Court and also to the High Court.


A separate circular will be issued to utilize the STAT HUB Application alone to send monthly statements from the District Judiciary to the High Court by dispensing the Paper Statements.
