

PROCEEDINGS OF MEETING OF SELECTION COMMITTEE TO DRAW THE TIME LIMITS FOR COMPLETION OF PROCESS OF SELECTION OF LEGAL AID DEFENSE COUNSEL UNDER LADCS SCHEME

On **16.08.2023**, a meeting of Selection Committee was held under the Chairpersonship of District & Sessions Judge-cum-Chairman, District Legal Services Authority, Faridkot to draw the time limits for completion of process of selection of legal aid defense counsel under LADC Scheme.

Secretary, District Legal Services Authority, Faridkot has put up before the Committee the letter No. **5538** dated **21.07.2023** of Punjab State Legal Services Authority, S.A.S. Nagar (Mohali) whereby directions have been issued to complete the entire process of engagement of Legal Aid Defense Counsels by **31.08.2023** and to submit the final result in a sealed envelope along with proceedings to the State Authority.

Secretary, District Legal Services Authority, Faridkot has further stated that total **05** applications have been received for the post of Chief Legal Aid Defense Counsel and **05** applications of Deputy Chief Legal Aid Defense Counsel. So, total 10 candidates shall be interviewed by the Selection Committee.

After due deliberations, the Committee has unanimously resolved that interview/interaction of the candidates shall be carried out in the post lunch session on 19.08.2023. **The candidates for the posts of Chief Legal Aid Defense Counsel and Deputy Chief Legal Defense counsel, shall be called on 19.08.2023 at 02:00 PM in the Chairperson Lounge of the District legal Services Authority, Faridkot.** Secretary, District Legal Services Authority, Faridkot has put up alphabetical list of candidates for the post Chief Legal Aid Defense Counsel System and Deputy Chief Legal Aid Defense Counsel System and according to the list they shall be called as per following arrangements in the retiring room/chamber of the undersigned:-

In case any candidate remains unable to appear before the Selection Committee on the date fixed for his interview, the Chairperson, Selection Committee will not allow him/her to appear on some other day for interview.

Before start of process of interview, Scrutiny of applications shall be made. It is unanimously resolved that the applications shall be scrutinized by the Selection Committee before 17.08.2023. The candidates shall be given opportunity to complete the deficiencies and produce the requisite documents before 18.08.2023.
