
Subject:- Order dated 16.03.2021 passed by Hon'ble Supreme Court of India in Writ Petition No.534/2020 titled as Bajaj Allianz General Insurance Company Private Limited Vs. Union of India & Ors.

ORDER

In view of the instructions contained in Hon'ble High Court letter No.1020/Spl.Gaz.II.17 dated 13.08.2021 vide which directions were issued that each Presiding Officer of Motor Accident Claims Tribunal be allotted specific Police Stations for the purposes of filing Accident Information Reports (AIRs), Detailed Accident Reports (DARs) and timely re-allocate the same in case of any addition/withdrawn of Motor Accident Claims Tribunal, the following Police Stations are re-allocated to the Presiding Officers of the Motor Accident Claims Tribunal for the purpose of filing Accident Information Reports (AIRs) and Detailed Accident Reports (DARs) etc:-


The concerned Presiding Officers are directed to ensure compliance of the directions of the Hon'ble High Court.
