PUBLIC NOTICE

This office has issued public notice bearing Endst. No.2489/EB dated 25.08.2023, inviting applications for the one (01) post of the Driver (on Ad-hoc basis) for a period of six months or till the regular appointment is made by the Hon'ble High Court of Punjab and Haryana, Chandigarh, as per the terms and conditions of the Public Notice.

In response of said public notice, 50 candidates have applied for the post of driver (on Adhoc basis). Out of them, 40 candidates applied against the category advertised are eligible (**Annexure-A**), 02 candidates did not mention the category in the application (**Annexure-B**), 07 candidates applied in category General/OBC/BC i.e. not against the post which was advertised, such applications are rejected (**Annexure-C**). One application received after due date, which is rejected (**Annexure-D**). The candidates as per Annexure-A, are given a chance to remove the discrepancies/objections on the date of Driving Test/exam as mentioned against their names and candidates as per Annexure-B, will be allowed only after producing the original documents of the category post advertised at the time of Driving Test/exam otherwise their application will be treated as rejected.
