PROCEEDINGS OF MEETING OF SELECTION COMMITTEE REGARDING MODALRIES OF SELECTION PROCESS

Today on 17.09.2024, a meeting of Selection Committee was held under the Chairmanship of District & Sessions Judge-cum-Chairperson, District Legal Services Authority, Faridkot to discuss the selection process of the Legal Aid Defense Counsel.

Secretary, District Legal Services Authority, Faridkot has stated that 23 application forms have been received from the candidates in pursuance of advertisement for the post detailed below:-

Sr. no.	Name of the Post	No. of Posts
1.	Assistant Legal Aid Defense Counsel	01

Secretary, District Legal Services Authority, Faridkot has further stated that total 23 applications were received for Assistant Legal Aid Defense Counsel.

After deliberations, the committee has unanimously resolved the criterion for selection of Assistant Legal Aid Defense Counsel.

Criteria for Assistant Legal Aid Defense Counsel shall be as under:-

- The candidate shall be selected purely on the basis of merit taking into account
 the knowledge and understanding of criminal law, ability to work with others,
 writing and research skills, understanding of ethical duties of Defense Counsel,
 IT knowledge with high proficiency in work and oral and written
 communication skills.
- 2. Each candidate shall be rated at the scale of 100 marks as per the following table:-

a.	Knowledge and understanding of law	25 marks
b.	Understanding of ethical duties as defense	25 marks
c.	counsel Knowledge of information and technology	25 marks
d.	Communication skills	25 marks

- 3. The candidate must have practice in criminal law from 1 to 3 years.
- 4. The candidate must have a license to practice issued by Bar Council.

Besides the aforesaid criterion, the qualifications, conditions and the guidelines issued by National Legal Services Authority, New Delhi shall be adhered to while selecting the candidates.

After interview the result of selected candidates shall be prepared and sent to the Punjab State Legal Services Authority, Faridkot.

Before start of process of interview, Scrutiny of applications shall be made. It is unanimously resolved that the applications shall be scrutinized by the Selection Committee before 17.07.2024. The candidates shall be given opportunity to complete the deficiencies and produce the requisite documents before 20.09.2024.

A waiting list shall also be prepared along with the list of selected candidate for the period of Six Months.
