

OFFICE OF THE DISTRICT AND SESSIONS JUDGE KORBA (C.G.)**ORDER****No. 35 / I-11-1/2019****Korba, Dated 26 / 02 / 2024**

1. In the exercise of power vested in, said by virtue of Section -10 (2)(3) and 194 of the Code of Criminal Procedure Act. 1973 and Section-15 of the Chhattisgarh Civil Court Act.1958 , I Satyendra Kumar Sahu, District & Sessions Judge Korba (C.G.) here by distribute the Civil business among the Court of Korba Civil District.
2. The Chief Judicial Magistrate, Korba shall distribute the criminal business among the Magistrates subject to the approval of Sessions Judge, Korba. Criminal Cases to be instituted in the Courts of Addl. Sessions Judge in the Sessions Division Korba shall be regulated by this Distribution Memo.
