- 1. संबंधित लिंक न्यायिक अधिकारी न केवल उस अदालत के अत्यावश्यक मामलों की सुनवाई करेगा, बल्कि यदि संभव हो तो उन मामलों का भी सुनवाई करेगा जिनमें गवाह अपनी गवाही दर्ज कराने आये हैं और यदि संभव नहीं हैं तो उन्हें बाध्य किया जायेगा और अगली तारीख दी जाये। पीठासीन अधिकारी के कार्यभार ग्रहण करने की तिथि से 3 दिन के अंदर उस अदालत की न्यायिक डायरी पर विचार करते हुये सरकारी गवाहों को छोड़कर अन्य गवाहों को बाध्य किया जाये, यही प्रकिया आपराधिक मामलों में भी लागू होगी। (रजिस्ट्री ज्ञापन कमांक 1475/डी एण्ड ए/2023 बिलासपुर दिनांक 08.11.2023 के अनुसार)
- 2. जब संबंधित न्यायालय का पीठासीन अधिकारी लंबी छुट्टी (ग्रीष्म या शीतकालीन अवकाश) पर हो तो उसके न्यायालय में लंबित कार्य योजना से संबंधित सभी मामलें जैसे कि पांच साल से अधिक समय से लंबित दीवानी, आपराधिक और निष्पादन के मामले एवं मोटर दुर्घटना आदि के मामलों में कार्य विभाजन अनुसार सुनवाई अन्य संबंधित पीठासीन अधिकारी/लिंक न्यायिक अधिकारी द्वारा की जायेगी। (रजिस्ट्री ज्ञापन क्रमांक 11520/डी एण्ड ए/2023 बिलासपुर दिनांक 29.11.2023।
- उपरोक्त कंडिका कमांक 1 एवं 2 में दिये गये निर्देश/अनुदेश वहां लागू नहीं होगा, जहां न्यायालय की संख्या एक ही है। (रिजिस्ट्री ज्ञापन कमांक 2134/डी एण्ड ए/2024 बिलासपुर दिनांक 03.02.2024)
- 4. वाणिज्यिक न्यायालय (जिला न्यायाधीश स्तर)/प्रथम जिला एवं अपर सत्र न्यायाधीश कोरबा के अवकाश पर या रिक्त होने पर मुख्यालय में उपस्थित वरिष्ठ जिला एवं अपर सत्र न्यायाधीश कोरबा के द्वारा अत्यावश्यक प्रकृति के कार्य का निष्पादन किया जायेगा और उनके भी अवकाश पर या रिक्त होने पर अन्य उपस्थित पीठासीन अधिकारी द्वारा अत्यावश्यक प्रकृति के कार्य का निष्पादन किया जायेगा
- 5. वाणिज्यिक न्यायालय (व्यवहार न्यायाधीश स्तर) के अवकाश पर या रिक्त होने पर, मुख्यालय में उपस्थित अन्य वरिष्ठ श्रेणी के पीठासीन अधिकारी द्वारा अत्यावश्यक प्रकृति के कार्य का निष्पादन किया जायेगा।
