Note -

1. The concerned Link Judicial Officer will take-up not only urgent cases of that court, but also take up the cases in which witnesses have come to record their evidence, if possible, and if not possible, they will be bound over and will give next date not later than 3 days from the date of joining of the Presiding Officer considering the judicial dairy of that court and bound the witnesses except the official witnesses, and in case the Link Judicial officer is also on leave, in his absence case will be taken up by as per work distribution memo ordered by Principal District & Sessions Judge Korba. It is also directed that, the same procedure will also be followed in Criminal Cases too.
2. If the Presiding Officer of any court is on long vacation (Summer and winter vacations), the Action Plan Cases of his Court, such as Civil, Criminal and Execution Cases pending for more than five years and Action Plan Cases such as Motor Accident Claims and other matters related will be heard by the other Presiding Officer as per work distribution memo ordered by Principal District & Sessions Judge Korba.
3. Serial No. 1 & 2 shall not be made applicable for the places where only one court is functioning and at such place, the work may be executed as per earlier directions/ instructions.
4. On the leave or Vacant of Commercial Court (District Judge Level)/Commercial Court (Civil Judge Level), the work of urgent nature will be executed by the other present Presiding Officer as per work distribution memo ordered by Principal District & Sessions Judge Korba
