In modification of this court's proceedings in the reference 1 to 6th read above, the Sessions Judge, Srikakulam is pleased to issue the following revised Instructions to the Judicial Magistrates of First Class In this District in suppression of earlier orders and instructions issued in this regard.

In respect of the crimes committed within the territorial jurisdiction of the Magistrates noted in Col.No.1 of the Annexure, the concerned police should normally file the necessary requisitions before the Magistrates noted in Col.No.2 for holding identification parades of the accused and properties for recording confessional statements of accused persons under secion 164 Cr.P.C.

In the event of absence from Headquarters of the Magistrates noted in Col.No.2 of the Annexure, the concjerned police should file the requisition before the corresponding Magistrates noted in 29/3 Col.3 thereof.

For recording dying declarations, requisitions from the Hospitals in the District other than the Headquarters Hospital, Srikakulam should be sent to the nearest Magistrate in whose territorial jurisdiction the injured persons hapopens to be present at that time. Similarly requisitions from the Headquarters Hospital Srikakulam should be sent to the I Additional Judicial Magistrate of First Class, Srikakulam,

In the absence of I Additional Judicial Magistrate of First Class, Srikakulam, the Principal Junior Civil Judge, Srikakulam shall attend to the recording of dying declarations.

In any contingency, the concerned police should approach the Sessions Judge, Srikakulam for necessary orders.
