

- ii) The above individuals are directed to complete their pending work and to handover detailed charge of their branches as per the directions of the respective Officers.
- iii) The Officer concerned are requested to relieve the individuals immediately after handing over of charge of their respective branches.
- iv) Any request for change of postings will not be entertained and such effort will viewed seriously.



- v) Concerned Presiding Officers and CMOs are requested to entrust work to all the employees transferred and joined in their respective posts by way of Office order and obtain acknowledgment as to entrustment of the specific branch.
- vi) It shall be the primary responsibility of the transferred employee to complete entire pending work and the Secondary responsibility will on the CMO/Superintendents or whoever is in that capacity to see that the pending work is cleared and detailed charge of their respective branch to be handed over.
- vii) Most of the individuals have opted stations at Srikakulam, Narasannapeta, Amadalavalasa and Ponduru. But however to maintain equilibrium and rational distribution of staff, options of some of the individuals could not be considered and options of the some of the individuals to the maximum possible extent is considered.
- viii) Request transfers sought by 38 staff members in all cadres, working in the Unit, for the present are not considered, keeping in view the total number of transfers due, in all cadres, during this summer vacation, are only 13 in number in the Unit, and also to avoid affecting administration, and smooth functioning of courts where they are working, and their request for transfer will be considered, at later point of time, basing on exigency of work.
