- 1. These Orders shall come into force with immediate effect.
- The appointee is informed that his appointment is purely temporary subject to verification of his/her
 antecedents and it does not confer any right of probation or reappointment and that he will be ousted from
 service at any time without notice and without assigning any reason.
- The appointee is informed that the documents produced by him/her are found to have been created, manipulated, interpolated or forged in future date they will be removed/dismissed from the service besides launching criminal prosecution against them.
- The appointee is directed to join duty on or before 05.08.2023 as per instructions of the Hon'ble High Court of A.P. otherwise, the Orders will be invalidated.
- The appointee is directed to produce physical fitness certificate issued by the Medical Officer not below the rank of Civil Surgeon at the time of joining duty.
- 6. The Presiding officers of the respective Courts are requested submit
 - a. Joining report to this Court by 5.30 P.M. of 05.08.2023
 - b. Physical Fitness Certificate
 - c. Agreement Bond as per Rule 21 (b) of A.P.J.M.S.S. Rules, 2019
- 7. The Officer concerned is requested to direct the appointee to execute an agreement bond that he shall serve the Department for a period of two years the completion of training as per Rule 21(b) of Andhra Pradesh Judicial Ministerial Subordinate Service Rules, 2019 and submit the same to the District Court, Kurnool.

- 8. If the appointee fails to serve the Department for a period of two years, for any reasons, or if he discontinues the training or is discharged from training course for misconduct or any other reasons, or if he secures any other employment elsewhere than under the State Government, he shall be liable to refund to the Government the pay and allowances or any other remuneration received by him in addition to the amount spent by the Government in his training as per Rule 21 C (i)(ii)(iii) of Andhra Pradesh Judicial Ministerial Services Rules, 2019.
- The individual is hereby informed that he will be covered by the contributory pension scheme and A.P. Revised Pension Rules, 1980
- The individual is informed that he should abide to the rules incorporated in G.O.Ms.No.76 LAW (L,LA & J Home Courts .A) Department dt. 15.05.2019 of the A.P. Judicial Ministerial Subordinate Service Rules .
- 11. The individual shall obtain a self fixed deposit receipt of Rs.10,000/- towards security for the due and faithful performance of his duties attached to within a month from the date of his appointment as per Rule 22 of G.O.Ms.No.76 LAW (L,LA & J Home Courts .A) Department dt. 15.05.2019 of the A.P. Judicial Ministerial Subordinate Service Rules .
- 12. The individual is informed that this proceedings does not confer permanent appointment and at any time his services are liable to be terminated without any notice in violation of above conditions.
- 13. The individuals are directed to produce one set of Photostat copies of educational qualification certificates at the time of joining duty before the Presiding Officer of the respective Courts, Where the individual is posted.
- 14. The candidates in the above proceedings who are now working in Other Departments are directed to submit Relieving certificate from their employer and submit the same in District Court, Kurnool before joining.
- 15. The candidates are further informed this proceedings are issued basing upon merit and their seniority will be fixed at a later date, as per guidelines of the Hon'ble High Court
- 16. The individuals are not entitled to any deputation allowance
- Selection against BC-E vacancy will however be, subject to the outcome of Civil Appeal Nos. 2628-2637/2010 pending before the Hon'ble Supreme Court of India.
- Selection against EWS vacancy will however be, subject to the outcome of Writ petition (Civil)
 No.343 of 2019 and other cases pending before the Hon'ble Supreme Court of India.
