

Execution of Agreement Bond under rule 21(b) of Andhra Pradesh

Judicial Ministerial and Subordinate Service Rules, 2019.

(To be executed on Non-Judicial Stamp worth Rs.100/-)

Know all men by these present that we (1)..... son/daughter of residing at (2)(surety) son/daughter of residing at.....bind ourselves, our respective heirs, executors, administrations and legal representatives, jointly and severally to the Governor of Andhra Pradesh (herein after referred to as the Government which expression shall, where the context so admits, include their successors or assigns or their attorney or attorneys) for payment to the Government equivalent to three months pay and allowances received by the above bounden (1)..... during the period of his/her training.

Whereas the above bounden (1) has been appointed to the Andhra Pradesh Judicial Ministerial under the Special Rules for the Andhra Pradesh Judicial Services as a of the said service and whereas he / she has to undergo training for a period of three months on pay Rs. /- a month , plus allowances admissible under the rules as applicable.

And whereas it has been agreed between the Government and the said bounden (1)..... that the above bounden (1)shall execute the above given in the above mentioned sum of the terms and conditions hereinafter contained with the above bounden (2) as surety.

Now the conditions of the above written bond are such that the above bounden (1) shall undergo the full period of training for three months and shall during such period of training abide by the conditions laid down by rules or Executive Instructions and shall after the completion of such period of training serve the Government in the above capacity in the Judicial department to which he/she is posted, for a minimum period of three years and if the said bounden (1) shall be prevented by a accident or ill health as certified by a competent medical authority, to the satisfaction of the appointing authority from undergoing the full period of training or from serving the Government for the said minimum period of three or if the above bounden (1) shall not be removed from service for any misconduct before the expiry of the said minimum period of three years that the above bounden (1) shall not be removed from service for any misconduct before the expiry of the said minimum period of three years if the above bounden shall, for reasons sufficient in the opinion of the appointing authority be unable to comply with all or any of the terms and conditions herein specified or if the above bounded (1) (2)(surety) shall at all times within thirty days of receipt of notice in writing, from the appointing authority, pay all sums of money that may become payable or above conditions or if the above bounden (1) shall duly and faithfully observe all these stipulations and conditions on his part to be observed and performed, then the above written bound or stipulation shall be void and be of no effect, otherwise, the bond shall remain in full force and the Government without prejudice to any other rights, may recover such sum of money as may be due from the above bounden (1)

(2)by virtue of this bound as if it were an arrear of land revenue under the Andhra Pradesh Revenue Recovery Act, 1864.
