Adverting to the above subject and references, I am to state that, as per the directions of the Hon'ble Chief Justice & Patron-in Chief and the Hon'ble Executive Chairman, APSLSA the National Lok Adalat is to be organized on 09-09-2023 (Second Saturday) as scheduled by NALSA.

As directed, all the Chairpersons of DLSAs are requested to take all necessary steps including the following:

- Identify more number of cases which are fit for settlement in National Lok Adalat to be held on 09-09-2023
- Give publicity as news item as many times as possible in respect of National Lok Adalat in the local press and electronic media.
- Shall have online Meeting with the Chairpersons of MLSCs and other Officers, well in advance sensitize them to identify more number of suitable pending cases for National Lok Adalat.

• The Chairpersons of DLSAs and MLSCs shall convene Meetings with Members of Bar Association and other Advocates and apprise them to take active part in the National Lok Adalat.

- To convene Meetings with other stakeholders viz., Police Officials, Insurance Companies, Bank Officials, Revenue Officials, A.P. State Road Transport Corporation, etc.
- Notices be issued in advance to all the parties from 01-08-2023 onwards.
- Take necessary steps to have Pre-Lok Adalat sittings and to conciliate between the parties to arrive at a settlement.
- Sufficient number of Lok Adalat Benches be constituted to avoid referring more number of cases to any of the Benches.

The Chairpersons of DLSAs shall instruct all the MLSCs in the district and others concerned, and ensure disposal of good number of pending cases in the ensuing National Lok Adalat to be held on **09-09-2023 (Second Saturday)**.

You are requested to submit weekly statement to this Authority by 4.00 p.m., on every Thursday beginning from 10-08-2023 in the enclosed proforma.
