Pursuant to this Court Official Communication in the reference 5th cited above, certain staff members working in various Courts in the Kurnool District got submitted their proposals through the Officers concerned along with their Service Books requesting to appoint them to the **Special Promotion Post Scale IA** under the revised Automatic Advancement Scheme as per G.O. in the reference 4th cited on completion of **12 years** incremental service in their respective posts.

Upon perusing the proposals and Service Books of the following staff members working in various Courts in the District got submitted by the Officers concerned for appointing them to the Special Promotion Post Scale IA on completion of 12 years of service in their respective posts, the undersigned is pleased to pass the following:

ORDER:

In the G.O. in the reference 4th cited, Government hereby ordered that the existing scheme of Automatic Advancement Scheme shall be continued as Special Grade Post after 6 years, Special Promotion Post Scale-IA after 12 years, Special Promotion Post Scale-IB after 18 years, Special Promotion Post Scale-IIA after 24 years and Special Promotion Post Scale-IIB after 30 years.

Special Promotion Post Scale IA (12 years) means as per G.O.96 in the reference 1st cited: An employee on completion of 12 years of service in a particular post shall be appointed to the Special Promotion Post Scale IA which is the next higher scale above the pay scale of the post he/she is holding.

Special Adhoc Promotion Post Scale 1-A (12 years) as per G.O.96 in the reference 1st cited in case the service rules do not provide for any promotion to the employee on completion of 12 years of service in a particular post shall be appointed to the Special Adhoc Promotion Post Scale 1-A which carries the next higher scale above the Special Grade Post Scale. Further, Govt. also ordered that if the service rules are changed imposing additional qualification for promotion after the entry of the individual into service, he/she shall be allowed the benefit of the next scale contemplated under Special Adhoc Promotion scale instead of denying the benefit of promotion and consequently the benefit of SPP-I/SPP-II scales. Those, who benefited from this dispensation, cannot claim the benefit of SPP-I or II even if they acquire the necessary qualification at a later date.

Fixation of Pay on appointment to Special Promotion Post Scale IA: The pay fixation on appointment to Special Promotion Post Scale IA shall be under F.R.22 (a) (1) r/w F.R.31 (2).

The following employees are appointed to the Special Promotion Post scale IA on verification of their Service Books as they have completed **12 years** of service in their respective posts with effect from the date as noted in Col.No.6 of the table below :
