- The appointee is directed to produce physical fitness certificate issued by the Medical Officer not below 5. the rank of Civil Surgeon at the time of joining duty.

 - b. Physical Fitness Certificate issued by the Government Civil Surgeon .
 - c. Agreement Bond as per Rule 21 (b) of A.P.J.M.S.S. Rules, 2019
- The Officer concerned is requested to direct the appointee to execute an agreement bond that he shall serve the Department for a period of three years the completion of training as per Rule 21(b) of Andhra 7. Pradesh Judicial Ministerial Subordinate Service Rules, 2019 and submit the same to the District Court,
- If the appointee fails to serve the Department for a period of three years, for any reasons, or if he discontinues the training or is discharged from training course for misconduct or any other reasons, or if 8. he secures any other employment elsewhere than under the State Government, he shall be liable to refund to the Government the pay and allowances or any other remuneration received by him in addition to the amount spent by the Government in his training as per Rule 21 C (i)(ii)(iii) of Andhra Pradesh Judicial Ministerial Services Rules, 2019.
