Adverting to the subject and references cited, I am to inform that the circular instructions issued in the reference 1st cited, are applicable to all *Courts, Authorities, Tribunals, Quasi Judicial Authorities, Forums or Commissions* functioning in the State.

Therefore, in terms of Section 12B(2) of the Advocates Welfare Fund Act, 1987 (Act 6 of 2023), every Interlocutory Application, Miscellaneous, Revenue Petitions and Criminal Miscellaneous Petitions, filed by Advocates, before any Court, Authority, Tribunal, Quasi Judicial Authorities, Forum or Commission, including the Interlocutory Applications and petitions filed by the Law Officers appearing for the State and Central Governments and their instrumentalities, shall be affixed with the Stamp worth of rupees twenty and no such Interlocutory Application or Petition shall be valid or accepted without such Stamp.
