All the Unit Heads in Andhra Pradesh are hereby informed that the Government of India in exercise of the powers conferred by sub-section (2) of section 147, sections 149, 159, 160, 161, sub-section (2) of section 162, sections 164A, 164B and clause (k) of sub-section (2) of section 164C of the Motor Vehicles Act, 1988 (59 of 1988), made the Central Motor Vehicles (fifth Amendment) Rules, 2022, amending the Central Motor Vehicles Rules, 1989.

While inviting attention to the said Rules, all the Unit Heads are requested to cause communication of the amended rules among all the Additional District Judges in particular Chairmen, Motor Accident Claims Tribunals functioning in their respective Districts, to adhere to the said Rules while dealing with the cases filed under M.V.Act and in particular for strict compliance of Stage-2 of Form XX of the Central Motor Vehicles (fifth Amendment) Rules, 2022.
