

The present Petition seeking Special Leave to Appeal is being filed against final Order dated 07.10.2023 passed by the Hon'ble High Court of Andhra Pradesh at Amaravati in Civil Revision Petition No. 1972 of 2023, which was pleased to pass an Order in C.R.P. No. 1972 of 2023, thus refusing to interfere with the Order of the Ld. Trial Court by which I.A. No. 229 preferred by the Petitioners in O.S. No. 30 of 2015, seeking for the Ld.
