As per Section 4(1)(a) of the R.T.I. Act, 2005 every Public Authority shall maintain all its records duly catalogued and indexed in a manner and the form which facilitates the right to Information under this Act and ensure that all records that are appropriate to be computerized within a reasonable time and subject to availability of resources, computerized and connected through a network all over the country on different systems so that access to such records is facilitated. As per sec.4(1)(b) of R.T.I. Act, that every public Authority shall publish certain information viz., data proforma is enclosed here to .

Hon'ble High court through the reference above has directed to take steps forthwith to place detailed disclosures under sec.4(1)(b) of R.T.I. Act in both English and Telugu on respective e-courts website under a separate section as "Disclosures under the R.T.I. Act, 2005" and to update the said information of their courts from time to time .

In view of the above , all the Judicial Officers shall comply with the said mandatory provisions of the Right to Information Act as mandated U/Sec.4(1)(b) for convenience of the Petitioners use and to take steps forthwith to place detailed disclosures U/Sec.4(1)(b) of the R.T.I. Act in both English and Telugu on respective e-courts website of their Courts , under a separate section as "Disclosures under the R.T.I. Act, 2005" and to update the information from time to time and to submit the following :

(1) Prescribed data proforma and U/Sec.4(1)(b) of the R.T.I. Act

(2) A certificate of uploading the said information in respective e-courts website for the year 2024
