QUALIFICATIONS:

A person -

- 1. Who has held any post in Andhra Pradesh Higher Judicial Service or State Judicial Services and Retired or Resigned, or
- 2. Who has held a post in the Andhra Pradesh Judicial Ministerial Service not below the rank of Superintendent of Junior Civil Judge's Court and has a Law Degree; or
- 3. Who has held a post of Section Officer and above in the Andhra Pradesh High Court Service and has a Law Degree; or
- 4. A non-practicing Advocate with a practice at the Bar for not less than Five Years and who is above 45 years of age and obtained a Certificate of suspension of practice issued by the Bar Association; or
- 5. Any retired Gazetted Officer possessing Law Degree or who has passed the Criminal Judicial Test (full text consisting of the Indian Penal Code and the Code of Criminal Procedure) conducted by the Andhra Pradesh Public Service Commission and who has exercised Magisterial Powers during his tenure of service for not less than three years, and
- Who has at least one year to complete 65 years, of age at the date fixed by the Court in the year of recruitment shall alone be eligible.
- 7. The applicant who intends to submit his application under Clause 4 shall enclose a Certificate from competent authority to the effect that he had a practice at the Bar for not less than five years together with another Certificate of Suspension of Practice issued by the State Bar Association.
- 8. In case the applicant is a retired Officer of Revenue Department, a Certificate from the competent authority to the effect that he had exercised Magisterial powers for not less than three years during his tenure of service in the Gazetted cadre shall be enclosed.

Provided that a suitable retired Judicial Officer shall be preferred.

DIS-QUALIFICATIONS: II.

A person -

- who is a practicing advocate; or 1.
- who is a member of any State or Legal Authority; or 2.
- who is a Member of the State Legislature or of the Parliament; or
- a person, who having held an officer under the State or the Union Government or any 3. local authority, has been dismissed or removed or compulsorily retired from service or 4. subjected to any major penalty for misconduct, or
- a person, who has been convicted and sentenced by a Court for an offence involving moral delinquency or is charged of any offence constituting moral turpitude and proceedings are 5. pending; or
- a person of unsound mind or who is deaf or mute or blind or suffering from leprosy or any 6. other contagious disease; or
- a person adjudicated as an insolvent or an un-discharged insolvent; or 7.
- a contractor or a business man or one interested in a subsisting contract or any work being done for Central or State Government or a local Authority within whose limits the Special Judicial Magistrate has to discharge his duties, shall not be eligible.

- Powers conferred by the Court on Special Judicial Magistrate of II Class shall 2. automatically stand withdrawn on his / her attaining the age of $65\,\mathrm{years}$.
